FAIR TREATMENT OF SEAFARERS IN THE EVENT OF A MARITIME ACCIDENT

Introduction

- At the 103rd session of the Legal Committee, the representative of the International Transport Workers' Federation (ITF) reported on the further analysis of the replies from Member States to the survey circulated by Seafarers' Rights International (SRI) on behalf of ITF and the International Federation of Shipmasters' Associations (IFSMA) concerning the 2006 *Guidelines on fair treatment of seafarers in the event of a maritime accident* (the Guidelines) (LEG 103/5).
- ITF further informed the Committee that it was preparing guidance for States on the implementation of the Guidelines, drawing on all the materials, answers and comments that it had received in response to the survey. In view of the different approaches that States had taken in implementing the Guidelines, ITF had suggested that an effective way to promote the Guidelines would be to organize regional or national workshops to discuss and refine the guidance being prepared, to make it useful for as many States as possible.



Numerous delegations spoke in support of the organization of a workshop on the implementation of the Guidelines. In the ensuing discussion, the following view amongst others was expressed: "Member States were mindful that they had different approaches in interpreting and implementing the Guidelines and that the organization of a workshop to develop a guidance on the Guidelines would therefore be a great opportunity to adopt a common and consistent approach for their effective and uniform implementation" (LEG 103/14, paragraph 5.4).

Further work

- A one-day workshop in London on the implementation of the Guidelines will be held on Friday, 23 June 2017 for the purpose of developing guidance on the Guidelines, for further submission to LEG 105.
